(1) Register with the Department of Trade and Industry Philippines	(1) Register with the Securities and Exchange Commission
(2) Registration with the Bureau of Internal Revenue (BIR) After registration with SEC the company shall be registered with the Bureau of Internal Revenue (BIR) to comply with tax related registration. We shall register the company book of accounts as required by the Internal Revenue Code of the Philippines and assist in the printing of Invoice and Official Receipts. Timeline for BIR registration is 1 week. Printing of Invoice and Official Receipts vary on the capacity of printers.	
(3) LGU (Local Government Units) Permits Registration for Business (City) Permits is done simultaneously with the registration of BIR. This process requires us to go through application for the following:
